

GENERAL INFORMATION

Camp Okee Sunokee is a six week day camp that encourages the development of recreation and social skills through participation in a variety of activities including arts & crafts, sports & games, music, cooking, swimming, and trips. Self-confidence and educational growth are enhanced through participation in the many activities offered.

NEW

The program is structured for children with a learning disability or Aspergers Syndrome. Eligible classifications, as stated in the child's IEP, may include specific learning disability, and communication impairment or a diagnosis of Aspergers Syndrome. Campers must be able to function in a group setting of 10 campers and 2 staff with minimal assistance and minimal verbal cueing and must be able to regularly participate without 1:1 assistance. Evaluation of the child in the school setting is a required part of the registration process for all new campers and may be required for returning campers. Transportation is not provided. No more than forty campers will be accepted.

It is the discretion of the TR staff to determine if your child is appropriate for the program as we want the camp experience to be fun and safe for all campers and staff.

An extended day program is available before and after camp hours at an additional cost but must be contracted for prior to the beginning of camp. *There are a limited number of spaces available in the extended day program.*

STAFF

Camp Okee Sunokee employs carefully selected, experienced staff. A Camp Director supervises the camp program. One Senior Counselor and one Counselor are assigned to each group of campers. The Camp Director is the TR department's Sr. Program Coordinator. The Senior Counselors have degrees in special education, therapeutic recreation, education, art, music, physical education or a related field. The camp employs activity specialists with expertise in the areas of arts & crafts, sports, games, and music. A medically trained staff person is also present at the camp site from 9:00am to 3:00pm.

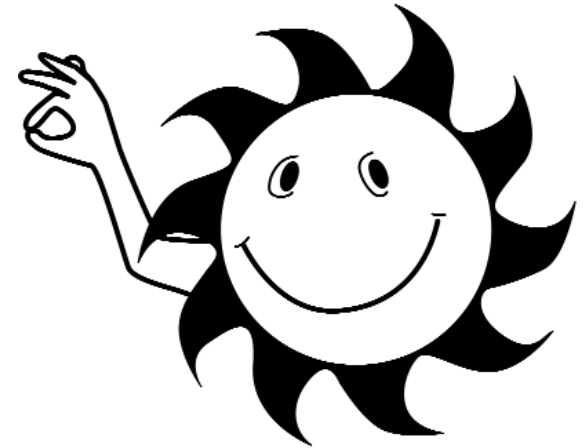

REGISTRATION

Please complete the attached "camper application" form and submit it with a \$75.00 deposit to start the application process. This deposit will be returned if the TR staff finds your camper ineligible or if there are no spaces available.

Registration will be accepted beginning Wednesday, February 23 from 6:00–7:00pm at North Branch Park TR Activity Center, 355 Milltown Road, Bridgewater. Snow date is Thursday, February 24 at the same time. No registrations will be accepted prior to February 23. After February 23 you may register between 8:00am–4:30pm by mail or by walking in your registration to North Branch Park.
