2012 Swim Lesson Information

Toddlers (Ages 2-4)

Orientation to the small and large pool for small children and parents. Parents will be taught along with children so that instruction may be reinforced by parents during weekly visits to the pool. Instructors will work with parents during the instruction portion of the class.

Objectives of the Toddler Class

- Assist children in overcoming their fear of the water.
- Provide children with fundamentals of breath-holding beneath the surface.
- Teach children how to close their mouths when exhaling beneath the surface.
- Teach children how to open their eyes beneath the surface (count fingers and retrieve small objects from the bottom.
- Provide continual reinforcement of pool safety and rules.
- Teach proper leg kicking technique.
