### PLANNING AND LAND ACQUISITION

Director Hayes introduced Tom Boccino, Park Commission Principal Planner/Land Acquisition, to share recent news regarding an upcoming land acquisition. Tom shared that Somerset County authorized its largest open space acquisition in two decades by authorizing the purchase of Hillsborough Country Club. The property is comprised of 402 acres, 5 buildings, and will provide about a mile of frontage along the Neshanic River. This acquisition will also expand the size of the Sourland Mountain Preserve and has impressive views of the surrounding area. Hillsborough Township will be contributing some funding towards the project, and the site will also receive Green Acres funding. A master plan will be developed to discuss "re-wilding" the site and potential uses for the existing building structures. Tom also mentioned that about 15 acres around the buildings will not have any restrictions as part of the Green Acres program.

Manager of Golf Operations, Ken Fivek, said that the gift card sale is underway and on the first day Golf Operations staff has already sold \$705,000 worth of gift cards.

Janine Erickson, Administrator of Executive Services, shared that the winning photographs of the 2023 Photo Contest will be displayed in the foyer at SCPC headquarters.

Adam Bloom, Park Commission Engineer, provided an update on his engineering report. The bridge project at the Green Knoll Golf Course is about 2/3 completed. Now that the bid opening has passed for the Warrenbrook Pool and pickleball projects, the anticipated award date for those projects is March 12<sup>th</sup>. There will be a \$60,000 incentive for the Warrenbrook Pool if the vendor meets the deadline, with a break-even date of July 15<sup>th</sup>. Commissioner Drake asked about pickleball at other SCPC parks and the reservation logistics for those pickleball courts. Stephen Dahl shared that there are pickleball courts at Colonial Park which utilize a reservation fee system. SCPC attendants put out the nets for the reserved games. He also stated that the pickleball courts have increased in popularity and the public has asked the SCPC to host a pickleball tournament.
