Director Soriano relayed concerns raised by the Supervisor at Buck Garden that parking on Layton Road by visitors to the garden is becoming problematic. The Supervisor questioned whether the Park Commission should be alerting Far Hills Police to monitor the roadway. Director Soriano raised the concern to NJRM who advised that the Park Commission is not obligated to do anything because parking is permitted on Layton Road. Counselor Bernstein stated that the Park Commission cannot direct garden visitors on what to do outside of the garden. If Far Hills Township finds there to be an issue, they will reach out to Director Soriano with their concerns, which can be addressed at that time.
