Dina stated that artwork created by TR participants in an art program at the Somerset ARC and part of an art show is now on display in the TR wing. Lastly, Dina announced that she will be retiring from the Park Commission on December 31st after 34 years of service.

COUNTY COMMISSIONER REPORT

County Commissioner Drake attended a workshop at Duke Farm on Deer Management. Staff from Duke Farm informed attendees of the various methods that are being utilized to manage the deer population at the farm, including the use of deer fencing. Managing the deer population has enabled staff to work on other projects that would otherwise be damaged by deer. Duke Farm is also working on management of invasive plant species on the property. Commissioner Drake expressed how fortunate it is to have Duke Farm in Somerset County.

OLD BUSINESS

CACI-Inc is interested in continuing its ability to do radio testing at Ross Farm. The Commissioners recommended that this request be forwarded to the Property Management Committee for consideration and the possible need for a permit.

Jenny Chipparullo who runs Lionheart Farm Project is seeking use of County-owned land as a location for a farm project. The purpose of the project is to teach farming skills to individuals with intellectual and developmental disabilities. The Commissioners recommended that this request be forwarded to the Property Management Committee for consideration.

Director Soriano informed the Commissioners that he granted permission in accordance with the Park Commission's UAF (Drone) Policy to Gene Huntington from Steward Green,

LLC. Mr. Huntington sought permission to fly a drone over Colonial Park to collect data in connection with a Rutgers University deer density study. The Commissioners supported the Director's decision.

Director Soriano referred back to the house at Lord Stirling that will be vacated by Gary Freuler at the end of the month and the need to confer with Principal Planner, Tom Boccino, on whether it has any historical value requiring its preservation. The Commission will need to decide a course of action for the property.

NEW BUSINESS

County Commissioner Drake stated that Jennifer Loughran of Bridgewater Skateboarding made a presentation to the County Commissioners at the last meeting expressing the need for a location for its skateboard program and seeking the use of the Greenway Park. Commissioner Drake believes that the Greenway Park could be an ideal location for the installation of a temporary skate park with the potential for a more permanent facility and requests the Commission's consideration of same. The Commission believes this request requires further discussion with the Leisure Services Committee followed by the Property Management Committee.

Seeing no further business, a motion to adjourn the meeting at 4:30 P.M. was moved by: Commissioner Caliguire; seconded by: Vice President Foelsch.
