Doug Vornlocker, Manager, shared that the Somerset County Park Commission received a \$10,000 grant from New Jersey American Water which will be utilized to plant trees along the river at Duke Island Park on November 4th. He also shared that new trail cams have been successful in efforts to reduce illegal dumping on park parcels and that staff have been working with the appropriate police departments.
