

**SOMERSET COUNTY PARK COMMISSION
RESOLUTION AWARDING FIRST YEAR OF A TWO-YEAR CONTRACT
FOR FURNISHING AND DELIVERY OF IRRIGATION REPAIR PARTS FOR
IRRIGATION SYSTEMS FOR GOLF COURSES OF
SOMERSET COUNTY PARK COMMISSION CONTRACT NO. PCC-0016-18**

WHEREAS, the Director of Finance and Administrative Services and CFO of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the temporary budget of the Somerset County Park Commission \$10,000 (31-201-20-851-214-803), \$500 (31-201-20-852-314-311), \$750.00 (31-201-20-853-402-274); and

WHEREAS, the Somerset County Purchasing Office did on January 30, 2018 advertise on the Park Commission website www.somersetcountyparks.org, and on the Somerset County website www.co.somerset.nj.us; and

WHEREAS, three (3) sealed bids were received, opened, and read in public on February 9, 2018 at 2:30 pm prevailing time for Furnishing and delivery of irrigation repair parts for irrigation systems for golf courses of Somerset County Park Commission, Contract No. PCC-0016-18; and

WHEREAS, the bids were reviewed and it was determined that the bids as submitted by Storr Tractor Company, Aquarius Irrigation Supply, Inc and Site One Landscape Supply, meet the requirements of the Park Commission specifications; and

WHEREAS, Storr Tractor Company, Aquarius Irrigation Supply, Inc and Site One Landscape Supply, submitted the lowest responsible bids on particular items.


