

**SOMERSET COUNTY PARK COMMISSION
RESOLUTION AWARDING THE CONTRACT FOR THE PURCHASE OF ONE (1) LASTEC PULL
BEHIND MOWER 521XR AND
TWO (2) LASTEC PULL BEHIND MOWER 721XRT AND OPTIONS
CONTRACT #PCC-9031-18**

WHEREAS, the Director of Finance and Administrative Services and CFO of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the capital budget of the Somerset County Park Commission: \$62,880.00 (34-215-17-045-307-401); and

WHEREAS, the Somerset County Park Commission Purchasing Office did on February 12, 2018 advertise in the Courier News, on the Park Commission website www.somersetcountyparks.org and on the Somerset County website www.co.somerset.nj.us; and

WHEREAS, one (1) sealed bid was received, opened, and read in public on March 6, 2018 at 2:30 pm prevailing time for One (1) Lastec pull behind mower 521XR and Two (2) Lastec pull behind mower 721XRT with options fourteen (14) anti-scalp blade, Contract #PCC-9031-18; and

WHEREAS, the bids were reviewed and it was determined that the bid as submitted by Finch Services, 1127 Littlestown Pike, Westminster, MD 21157 meets the requirements of the Park Commission specifications.


NOW, THEREFORE, BE IT RESOLVED by Somerset County Park Commission that the bid be accepted for the following:
