

Guidelines for Participation as an Exhibitor

- Applications (please print neatly or complete digitally) due by Wednesday, November 15, 2023 at Noon
- Return application to Monica Juhasz: <u>mjuhasz@scparks.org</u> or fax 908-766-2687
- Confirmation of participation and other correspondence will be emailed
- Exhibitors accepted on a first-come, first-served basis, as space is limited
- All trees must be artificial and a minimum of 3' tall
- A table must be provided for trees 4' tall and under
- You must provide an appropriate, free-standing, tree stand to support your tree
- You must provide an extension cord if lit (please label)
- If your decorations are 'home-made' please arrive with them completed
- Displays may not contain any kind of edible food items or tinsel
- Displays must be removed by 4:30pm on Wednesday, January 3, 2024
- Festival open daily 9:00am-4:30pm from December 1 to 28, 2023 (Closed- December 22, 24, 25)
